Corporate Profile

General Moly is a U.S.-based molybdenum mineral development, exploration and mining company listed on the NYSE MKT (formerly the NYSE AMEX) and the Toronto Stock Exchange under the symbol GMO. Our primary asset, our interest in Mt. Hope, a primary molybdenum project located in central Nevada, is fully permitted. Preliminary construction activities have begun at Mt. Hope with heavy construction to coincide with warmer weather and the closing of remaining financing in the spring of 2013. Mt. Hope is considered one of the world's largest and highest grade molybdenum deposits. Mt. Hope is differentiated from other moly projects through its strategic partnerships with blue chip companies that (1) agreed to arrange substantially all of Mt Hope's project financing, (2) provided offtake commitments (first five years at 100%) and (3) committed to a hard price floor for approximately half the offtake production over the first five years at between \$14-\$15 per pound on average. Combined with our second molybdenum property, the Liberty project which is also located in Nevada and is currently at the pre-feasibility stage, General Moly's goal is to become the largest pure-play primary molybdenum producer in the world.


